Dress Code Discussion Follow Up

- 3. Group sections E,F,G & H from the current dress code into one gender neutral generic statement
- 4. Adopt the recommendations from the Student School Board regarding hats
- 5. Add pornography to section C regarding printed apparel

National Honor Society (NHS)

The council reviewed the current MHS NHS Bylaws

Recent changes (2020) were made to the qualifying GPA for NHS. This confused students who were unaware of the changes and thought they would qualify for NHS this year.

Some parents wondered why only Juniors and Seniors are eligible to participate in NHS.

The National Organization has broad standards and each district and/or school can set more specific standards.

We discussed the need to define the pillars in the Bylaws and forming a committee consisting of teachers, a counselor and an administrator to review applicants.

Mr. Wilson asked the CC members to review the current policy and discuss specific recommendations at a future meeting.
